What You Get in a Package

When a group purchases a license to use a package (usually ~ 30 pages), the package is delivered via e-mail as a pdf attachment to a designated person in the group who is entrusted to deliver copies to the group.

In addition to tablature, each package is supported by sound files on the Internet. Each group member can access these and listen to his/her part(s). Or she/he can play one part against other parts played on the computer. Therefore, the group can practice at home before coming together. There are also suggestions for arranging the parts.

I have created these packages to make it much more economical for groups to have high quality, multi-part dulcimer arrangements to perform. For example, a large group of 15 could purchase all four packages, and every person in the group could have about 120 pages of tab for about \$13 apiece. A book would probably cost about \$40 per person. The group can pay one price and make enough copies for each person in the group. Of course, to do this, I depend on the integrity of dulcimer groups.

I ask that groups not distribute unlawful copies of these packages either electronically or otherwise. I also ask that they do not put them on a website with public access. Each package is restricted for use by the group for whom the license was purchased.
